2	WHEN YOU MUST LODGE YOUR APPLICATION AND PAY	<p>Your completed application (with photos) must be received by the Awards Secretary no later than 31 January in the year following the year in which the entry will be included.</p> <p>There is no charge if you are a member of an OSCOV Member Society, but there is a \$20 fee for any other person.</p>
3	REQUIREMENTS FOR PHOTOS	<p>Your photos should be in jpg form.</p> <p>You should consider providing 3 pictures – being 1 of the whole plant, 1 of an inflorescence and 1 of a single flower.</p> <p>Each photo:</p> <ul style="list-style-type: none"> • should be a minimum of 1.5MB size; • must fairly and truly represent the orchid awarded; • should have a dark or neutral backdrop; • must not include text or a date stamp; and • must not be electronically modified in any manner (other than cropping, which is permitted). <p>Every reasonable attempt will be made to return digital media (eg. a USB stick, CD or DVD) to you.</p>
4	WHAT MUST YOU DO IF YOUR ORCHID WAS <i>NOT</i> SEEN BY AN OSCOV PANEL?	<p>Your application must be accompanied by a photograph or video of you holding or standing beside the orchid.</p> <p>OSCOV may make additional inquiries of, or request additional information from, you including requesting that you arrange a video, Skype or similar visual phone-call so that OSCOV can verify that the orchid is currently in flower.</p>
5	SEEDLINGS	<p>If your orchid is a seedling – the grex must be registered by the RHS for your orchid to be eligible in the OSCOV Victorian Orchids of the Year.</p>
6	VICTORIAN ORCHIDS OF THE YEAR CATEGORY/IES	<p>Subject to this note 6 – your orchid will be entered into the appropriate category/ies in the OSCOV Victorian Orchids of the Year.</p> <p>The OSCOV Registrar will decide which category/ies are appropriate.</p> <p>If your orchid has not been seen by the OSCOV Panel – the Registrar will decide if your application is eligible in the Victorian Orchids of the Year.</p>
